

VOLUNTEER PROCESS

Welcome to the Boys & Girls Clubs of Central Wyoming! We appreciate your interest in volunteering with our program. The following information guides you through the steps to become an eligible volunteer. Highlighted are the steps to be completed by the volunteer applicant as well as the process. Please direct questions to Volunteer Coordinator – Amanda Montes, amontes@bgccw.org

- 1. To begin the process please fill out the Volunteer Application, Volunteer Criminal Record Release Authorization Form and Interest Survey below and return to BGCCW Main Office located at 1701 East K Street, Casper, WY 82601 or email to amontes@bgccw.org. Criminal background checks will be secured on all volunteers including minors.
- 2. Once forms are received by BGCCW the background check and reference check will be completed. If the volunteer applicant is eligible to move forward, the Volunteer Coordinator will contact you via email. Please check your email regularly for notifications throughout the process.
- 3. **BGCA and BGCCW require all volunteers to take a safety training prior to onboarding.** Once your background and reference check is complete we will send you **via email** instructions on completing the safety training, Foundations: Preventing Abuse in Youth-Serving Organizations. Setting up an account will be required to take the training and you will have access to your account for 20 days. The training takes roughly 45 minutes to complete. Once completed you will print and submit your certificate to the Volunteer Coordinator or send via email to the address below. If you need assistance throughout this process, please don't hesitate to contact us!
- 4. After completing the safety training, the Volunteer Coordinator will connect you **via email** with the Branch Director to complete an orientation, tour of the facility and to determine days and hours of your volunteer service. The Branch Director will be able to connect you with the activities you are most interested in and answer any questions you may have with your volunteer experience. At the end of your orientation you will sign a Volunteer Signature Page that will be submitted by the Branch Director to the Volunteer Coordinator.
- 5. Congratulations! You are now eligible to begin volunteering with the Boys & Girls Clubs of Central Wyoming. We know you will be a great addition to our organization and look forward to working with you!
